elects not to complete or provide for completion of the corrections, then Buyer shall ha	ive the
option of (iv) accepting the Property in its present condition, or (v) terminating this con	ntract, in
which case all earnest monies shall be refunded to Buyer. Buyer may waive the right t	o obtain a
risk assessment or inspection of the Property for the presence of lead-based paint and/o	or lead
based paint hazards at any time without cause.

Lead Warning Statement
